

ORDER

WHEREAS, in terms of Sub-clause (10) of Clause 8 of National Council of Teacher Education (Recognition Norms and Procedure) Regulations - 2014 and Section 26A of the West Bengal of Primary Education (WBPE) Act (amended up to date), 1973, the Secretary, Minerva Academy Primary Teachers' Training Institute, Murshidabad, has applied for change the medium of instruction of existing one unit (50 Intake) of Nepali Medium to Bengali Medium for continuing Two Year D.El.Ed Course on 16/05/2024 vide memo no. MEWS/MAPTTI/WBBPE/2024-05-01.

AND WHEREAS, on scrutiny of the application submitted by the institution, the WBBPE has decided to consider the prayer of the institute for change of medium of instruction from Nepali Medium to Bengali Medium of one unit (50 Intake) to conduct the Two Year D.El.Ed Course in terms of the provision of West Bengal Primary Education Act (amended up to date), 1973 and the existing NCTE Regulations, 2014 for running the programme from the academic year 2024-2026 subject to the fulfilment of the following conditions:-

- (i) The institution shall comply with various other norms and standards prescribed in the WBPE Act, (amended up to date), 1973, and other WBBPE regulations/rules as issued from time to time.
- (ii) The institution shall make admission as per the regulations/norms of the WBBPE.
- (iii) The institution shall ensure that the approval of the newly recruited numbers of the faculty council for the new Bengali Medium unit.


